#### DRYER VENT CLEANING

The Mutual normally pays for cleaning dryer vents every three years. However, if your dryer suddenly takes longer than normal to dry your cloths do not, and I repeat, DO NOT continue using your dryer until you get the dryer vent cleaned. If your dryer is taking longer than normal, it can be because a blockage in the vent. Your dryer can overheat and start a fire. It is the home owner's responsibility to pay for vent cleaning outside of regularly schedule cleaning. The last time vents were cleaned was May 2019. They are next scheduled to be cleaned in 2022.

The Mutual uses Air Quality Technology for Dryer Cleaning 301-956-7254. Tell them you live in Mutual 16 and that they were contracted in 2019 to clean all 96 homes.

#### **AUTOMATED GATE SYSTEM**

We are getting closer and closer to the final stages of the new automated gate system. Harry **Geehreng** (Security and Transportation Committee) has heard questions from many residents and knows he doesn't always have an answer. To help address this, Harry made arrangements to have Mr. Dave Merritt, the gate access system's project manager, as the guest speaker at the recent Mutual 16 meeting via Zoom. This event was intended to be an opportunity to ask questions and find out what is planned. Harry hopes that residents were able to take advantage of this perfect way to participate.

#### **AUTOMATIC PAYMENTS**

There has been an increase in the number of residents' monthly assessment payments being considered late because they arrive at LW after the 16th of the month.

Be aware that if you use a Bill Payment Service, the payment is deducted from your account with them immediately — however, the Bill Payer Service takes some time in sending a check to LW accounting. In addition, post office delivery has not been timely recently.

As a solution, **Ellen Darr** notes that residents can sign up for Leisure World's automatic clearing house (ACH) — also referred to as the automatic debit plan. #### **FLUORESCENT LAMP DEAL**

Leisure World has obtained from Pepco — free — LED replacements for certain fluorescent lamps and is offering them to the Mutuals with the condition that home owners are responsible for installation. This offer is to, in a small way, reduce electric consumption. The LED lamps use about one-third the energy of the fluorescent lamps.

The lamps are 4 feet long, 1 inch diameter fluorescent replacements. They will replace a T8 lamp in a fixture with an electronic ballast. In addition to the lamp dimensions, you can also read the printing on one end of the lamp to verify that the lamps in your fixture are the T8 lamps. The printing will include this: "F32T8." They will NOT work in older fixtures with T12 lamps (1.5 inch diameter). The lamps are 4100k color temperature (k=Kelvin), which is a bright white color. Please note that these lamps are not meant to replace LED lamps in an LED fixture.



Helen grew up in Long Island and Connecticut and Bob in California. Bob majored in electrical engineering at Caltech — Helen majored in nursing and public health at Skidmore. He got a job in Massachusetts where a work buddy invited him for Thanksgiving and Bob met his coworker's sister. Helen. They married a year later. After the honeymoon, they moved to California for Bob's new job at Lawrence Livermore Labs and his PhD at UC Berkeley. Helen worked at the Alameda County Health Dept. Their first two children were born during their seven years there.

They've traveled extensively, visiting Asia, Europe, Central America, and more. They even went on an African safari. Closer to home, they spent summers camping with the kids. Yosemite was a favorite backpacking trip. Helen stood guard all night, banging a pot whenever she saw a bear sniffing around the campground.

In 2015, with the children's encouragement, Bob and Helen moved to Leisure World. Their Burtonsville home had become a lot of work. They've taken advantage of LW amenities — they have a garden plot, swim laps at the indoor pool, walk the golf course, and are in the Vegan Club and the Mac Club. Bob was on the LW Energy Committee and Helen was president of the LW Unitarian Universalists and in the Garden Club.

They've always worked as a team. At times, Bob worked days and Helen worked nights so a parent was always home for the children. In their garden plot, Bob built the raised beds, Helen cares for the plants, and they both weed. At their church, they taught classes together. They work on the Sudoku puzzle from the newspaper as a team. They make dinner together or take turns. Their philosophy: Live life rich in love of learning, love of family, and love of community. They celebrated their 61st anniversary in February.
