FROM THE DESK OF THE PRESIDENT

Unless you live in a cave, I'm sure you are aware that the price of everything has increased in the past few months. Unfortunately, the condo fees for our Mutual are no exception. Our Budget was presented at the October 12, 2021 Board of Directors (BOD) meeting. As detailed at that meeting, and in the letter* sent to all residents a few days afterward, our condo fee will increase an average of \$95 in 2022. A major portion of this (\$77) is property insurance expense. The rest of the increase is in Community Facilities, Mutual Operations, and the elimination of Prior Years Surplus revenue.

Over the past 10 years, the average monthly condo fee increased just 8.4% which included a \$25 overall increase in 2020 due to the addition of the new internet coverage. However, the insurance issue has forced this large increase.

The BOD plans to give final approval to the budget at the November 9 meeting.

I have received 5 requests from resident to serve on various Leisure World Advisory Committees. We still could use someone to serve on Audit, Energy, Emergency Preparedness, Health, Insurance, Physical Properties, Restaurant, and Tennis. If you are interested, please submit an application before October 25 to **Joan Allston** or any Board member. If you do not want to serve on a LW Advisory Committee, we could still use help with Mutual 16 Volunteer Activities. Contact any Board member to see where you could assist.

NEW & IMPROVED BYLAWS

There is a new improved copy of the Mutual 16 Bylaws on the M16 website (www.lwm16.com). Most copies have the changes to the bylaws over the past 40 years placed at the end of the 40 pages of original bylaws. It is difficult to figure out the current stipulations in the bylaws. The copy on the website has the amendments imbedded in the text (bolded) in the actual places that were changed. This makes it easier to keep up-todate on the governing documents for Mutual 16. An example: The date of the annual meeting was changed from the first Thursday of April to the 3rd Thursday in May in 1986 (Article IV, Section 2). Another example: The following was added to the bylaws in 1990: "All Units shall contain garage space to accommodate at least one car." (Article IX, Section 3, (p)). There are 11 additional amendments to the original bylaws.

Thank you to **Bob Bridgeman** and **Ed Bradley** for doing the cutting and pasting to make the Mutual 16 Bylaws easier to decipher.

WINTERIZE YOUR HOUSE

Before really cold weather arrives, winterize your home. These simple actions will keep your house warmer and safer from flooding.

- Disconnect all outside hoses from the faucet to reduce likelihood of frozen pipes.
- Drain the hose and put it away to prevent freezing and splitting.
- Close the air conditioner vents in the ceiling. This will reduce drafts.
- Remove the AC filter, clean, wrap with foil, and put it back to reduce drafts. Reverse this process before running the AC in the spring.

Some of the things Helping Hands has done since the last newsletter include fixing a Marine Corps flag of a female Korean War veteran so it won't keep falling out of the holder in strong winds, fixed a sliding cupboard shelf that was difficult to pull out and push in one of the tracks was bent so it just had to be straightened out to fix it, disconnected a tightly-attached hose, scraped flaking paint off a side garage door - also gave it a quick coat of paint (I had done the same with mine), and unstuck a couple of sliding windows.

If you need some help and aren't sure if **Helping Hands** can do what you need, here's some background information on jobs I have done in homes where I've lived.

The first was when I was 7 years old. My parents bought a used player piano they wanted to put in the basement family room. There was no outside basement entrance. My father figured we could remove a small basement window, remove some cinder blocks next to it, and slide the piano on its back into the basement. My job was to chisel out cinder blocks after I got home from school each day.

Jobs in homes I owned included building a deck for a screen porch, extending a driveway so two cars would fit on it, and installing a prefabricated fireplace – flush mount inside with a raised slate hearth.

These kinds of jobs will not be done here, but it lets you know that if you need some work done by a handyman, call **Helping Hands** at 301-740-6724 before hiring someone. The worst that can happen is you'll be told **Helping Hands** can't do it – and *then* you can go ahead and hire the handyman.

LEISURE WORLD LANDSCAPE ADVISORY COMMITTEE (LAC)

LAC approved a project to remove the *nandina domestica* (Heavenly Bamboo) at the entrance to Clubhouse 2. Why? It's a highly invasive species and we want to spruce up the landscaping in this area. LAC is advising Mutuals to avoid *nandina domestica* in their landscaping.

That said, any **other** variety of *nandina* is a beautiful option for the 4 feet around our homes.

Save the date: On December 1, McFall and Berry will place tree and shrub clippings at the shuffleboard court for residents to take for their holiday decorating. *Free!*

SENIOR CALL CHECK PROGRAM

A FREE SERVICE FROM THE MARYLAND DEPARTMENT OF AGING

HOW DOES IT WORK?

Every day a telephone call will be placed to a participant at a regularly scheduled time. These calls will take place between 8 a.m. and 4 p.m. as close as possible to the one-hour time block preselected by the participant. If the participant does not answer their first call, they will be tried two more times. If those calls go unanswered, additional calls will be made to notify an alternative person who is selected by the participant during program enrollment. This could be an adult child, a neighbor, or another loved one. The alternate will then be encouraged to check on the older adult program participant. The failure of the participant and alternate to answer will result in a call to your local non-emergency service.

WHO CAN PARTICIPATE?

Any Maryland resident who is 65 years of age or older who has a landline phone or cell phone (TTY is available). The participant and alternates should not have automated call blocking technology (or they should disable that phone feature for this program).

WHO IS AN ALTERNATE?

An alternate is a person you have selected to be called in the Senior Call Check program in the event you do not answer your automated call after 3 attempts. This person must be a reliable emergency contact, such as an adult child, a responsible neighbor, or a close relative. It is helpful to discuss the program with your alternate and explain their responsibility in being a support for you in the event you need help and do not pick up your daily call. If you do not have an Alternate Person, a Limited Alternate will be assigned to you. The program will notify your local nonemergency service after multiple attempts to reach you and your alternate.

HOW TO APPLY?

The online option is the easiest way. Just go to aging.maryland.gov/Pages/senior-call-check.aspx Otherwise, you can call 866-502-0560 (toll-free) and ask to have a hard-copy application mailed to your home. After all your info is validated, a Welcome Packet will be mailed to your home address. It will include your start date.

"FILE OF LIFE"

Do you have a red vinyl "File of Life" magnetically attached to your refrigerator door? If not, they are free at the Leisure World Medical Center. Keep it updated with info concerning medications, doctors, and contacts to be notified in case of serious illness. This information is very important to an emergency crew when they are called in due to a sudden illness. The rescue crew will check your refrigerator door for the "File of Life."

ROBO-CALLS:

The Mutual 16 President directs the robo-call system to alert residents about immediate situations in the mutual. It may be a notice about a repair that affects residents' water service, a last-minute change to a meeting time, or even a "silver alert" for a missing vulnerable neighbor. Ellen Darr manages the robo-call directory. To remove your listing, or switch it from land-line to mobile, contact ellenmdarr@gmail.com

TRASH SCHEDULE

Here's the schedule for garbage and recycling pickups, with specific requirements for each. Note: garbage and recycling night before their pickup days.

• GARBAGE: Pickup days are Tuesday and Friday. Be sure your garbage can is tightly covered.

- GLASS/METAL/PLASTIC RECYCLING: Pickup days are Tuesday and Friday. Recycling should be in the appropriate blue container. If you need a blue container, you can get one from PPD.
- PAPER/CARDBOARD RECYCLING: Pickup day is on Wednesday only. Paper/cardbood should be placed in a blue recycling container. Large boxes may be set out separately. Secure properly so paper doesn't fly around when it's windy.
- YARD DEBRIS: BY REQUEST ONLY on Monday and Thursday. Contact the Grounds Department 301-598-1314 to notify them you have yard debris for pickup. Use tall brown paper recycling bags. Phone calls are preferred, but you may also email grounds@lwmc.com.
