SMART COOKIES APRIL RECIPE

JUDITE FERNANDES'
GLAZED LEMON COOKIES



INGREDIENTS

- □ 1¾ cups flour
- \square ½ teaspoon baking soda
- ☐ ½ teaspoon salt
- ☐ 1 tablespoon lemon zest (about 1 small lemon)
- ☐ ½ cup unsalted butter
- ☐ 1 cup sugar
- □ 1 egg
- ☐ 1 teaspoon vanilla
- ☐ 2 tablespoons lemon juice Glaze
- ☐ 2 cups powdered sugar
- ☐ 2 tablespoons lemon zest
- ☐ 1/3 cup lemon juice

DIRECTIONS

- Preheat oven to 350° F.
- Prepare cookie sheet with non-stick spray or parchment paper, set aside.
- In medium bowl, whisk flour, baking soda, salt and lemon zest.
- In large mixing bowl, beat butter for a few seconds, add sugar, and mix until light and fluffy. Add in egg, vanilla, and lemon juice. Mix until fully combined.
- Continue mixing while adding dry ingredients. Mix until fully combined.
- Drop cookie dough by spoonful onto prepared cookie sheet. Bake until light golden on edges, approx. 12-14 minutes. Remove from oven, let cool on cookie sheet about 5 minutes, and then remove to continue cooling on wire rack.
- Once cooled, prepare glaze by whisking powdered sugar, lemon juice, and lemon zest together until well combined. Spoon on top of cookies. Allow to dry, glaze will harden.
- Store cookies in airtight container at room temperature. Enjoy!



SUMMARY: SPECIAL MEETING ABOUT INSURANCE 3/31/2022

The Mutual 16 Board of Directors called a special meeting on March 31st to discuss the Mutual's property and other insurances. Over thirty residents attended via Zoom.

Jeff Rice, an experienced homeowner's association insurance broker with Associated Insurance Management, LLC, presented a proposal from Greater New York Mutual Insurance Company. This proposal would replace Mutual 16's insurance coverage under the Leisure World Master policy. Mr. Rice presented a comparison between to the current Leisure World Master insurance policy and the proposed Greater New York Mutual Insurance Company policy:

- The Leisure World Master policy (StarStone Specialty) is issued by an A-minus rated company. The issuer of the proposed policy (Greater New York Mutual Insurance Company) is an A-plus rated company.
- The premiums for the Greater New York Mutual Insurance Company insurance policies are substantially less than the premiums for the Leisure World Master policy.
- The Mutual's deductible for the Leisure World Master policy is \$50,000. The deductible with the Greater New York Mutual Insurance Company is \$10,000.
- These benefits come at no loss of coverage for Mutual 16.

In answer to residents' questions, Jeff Rice stated:

- That switching the Mutual's insurance company will have no impact on individuals' insurance (HO-6);
- That according to the Maryland Condominium Act, Improvements and Betterments are not covered by any Commercial Policies; and
- That switching to Greater New York Mutual Insurance Company policies will not lower the monthly HOA fees at this time (during 2022.)

Melissa Pelaez and Crystal Castillo from LW management, reported that there are portions of liability that Mutual 16 will be responsible for under the Leisure World Master policy as well a responsibility for a portion of LWCC Board of Directors D&O (Directors & Officers) policy. They could not provide exact figures at this time.

Four resolutions were passed unanimously by the Board:

- To accept the proposal from Great New York Mutual Insurance company;
- To remove Mutual 16 from the Leisure World Master insurance program;
- To cancel our separate Fidelity Bond Policy; and
- To ban charcoal grilling as that would adversely affect the new insurance coverage per Rule 3.3 of the Mutual 16 Rules.

CHARCOAL GRILLS ARE NOW BANNED IN MUTUAL 16

As of April 1, 2022, the use of charcoal grills anywhere in Mutual 16 is banned.

This ban is required by our new property insurance company.

The use of a charcoal grill within Mutual 16 could jeopardize our future insurance coverage.

TRASH SCHEDULE

Here's the schedule for garbage and recycling pickups, with specific requirements for each. Note: garbage and recycling night before their pickup days.

- GARBAGE: Pickup days are Tuesday and Friday. Be sure your garbage can is tightly covered.
- GLASS/METAL/PLASTIC RECYCLING: Pickup days are Tuesday and Friday. Recycling should be in the appropriate blue container. If you need a blue container, you can get one from PPD.
- PAPER/CARDBOARD RECYCLING: Pickup day is on Wednesday only. Paper/cardbood should be placed in a blue recycling container. Large boxes may be set out separately. Secure properly so paper doesn't fly around when it's windy.
- YARD DEBRIS: BY REQUEST ONLY on Monday and Thursday. Contact the Grounds Department 301-598debris for pickup. Use tall brown paper recycling bags. Phone calls are preferred, but you may also email grounds@lwmc.com.
