SMART COOKIES MAY RECIPE

JANET GILBRIDE'S COFFEE BON BONS



INGREDIENTS

- □ 1 cup butter, softened
- ☐ ¾ cup confectioners sugar
- ☐ ½ teaspoon vanilla
- ☐ 1 tablespoon instant coffee granules
- ☐ 1¾ cup flour

Chocolate Glaze

- □ 1 tablespoon butter
- ☐ ½ ounce unsweetened chocolate
- ☐ 1 cup confectioners sugar
- ☐ 2 tablespoons milk

DIRECTIONS

- Cream butter, sugar and add vanilla.
- Combine flour and instant coffee, stir into butter, and mix well.
- Chill, then roll into ¾ inch balls on cookie sheet.
- Bake at 350° F about 15 minutes or until lightly browned.
- To prepare glaze, melt butter and chocolate. Add to confectioners sugar in mixing bowl, add milk, mix well. Frost cookies while still warm.



GET TO KNOW YOUR NEIGHBORS

CEOLA AND PETER LOAN 3402 PARKER CREEK LANE



They met in Ossining, New York: He an Irish-Catholic seminarian, she an African-American divorced mother of two. He was just back from two years as a missionary in Tanzania; she was a soprano in a gospel choir. He came to the choir's performance and it was "Some Enchanted Evening, You Will Meet a Stranger." Eighteen months later they were married.

They lived in a suburb of Boston at first, then moved to Zaire, now called the Democratic Republic of the Congo, where Peter's language skills in French and Swahili helped land him a job with the Peace Corps. Ceola provided training and consulting services in alcohol and drug abuse to the American community in Zaire while the children went to the American school in Kinshasa. During their three-year tour in Zaire, they experienced the first (little-known in the US) outbreak of Ebola, went on safari, experienced the cultural richness of the society, and met many wonderful people who are still friends today.

They returned to the US in 1979 and settled in the DC suburbs. The children went to Montgomery Blair High School. Peter worked for the Peace Corps, the Graduate School-USDA, and Sister Cities International, and as adjunct professor for several universities, while Ceola completed her undergraduate and graduate studies at UMD/UC and GW respectively. For 25 years, she trained service providers in cultural sensitivity at Rutgers University Summer School of Alcohol and Drug Studies. With the Robert

Woods Johnson Foundation, she helped establish school-based health clinics in 18 cities nationwide; and she served as the State Long-Term Care Ombudsman for the District of Columbia. For 32 years, Ceola also had a small antiques and collectibles business. They also formed their own consulting firm: Brown and Loan Associates. All the while, family came first. They were super hands-on parents, faithfully attending the children's school activities.


They say they retired in 2001 and 2014, but they have an unusual idea of retirement. Up to 2019 Peter continued to train federal, state and local government employees in grants management and Ceola continued her antiques business. Both took on writing projects. During their COVID confinement, Ceola published If I Can Help Somebody, accounts of remarkable human encounters; and Peter published Fever! And Other Stories from the Land of Mobutu, based on experiences in Zaire. Over the years, Peter's work took him to 45 countries on five continents, and together they have traveled to Kenya, Tanzania, Ireland, Jamaica, France, Aruba, Curacao, Canada, Japan and all over the US. Especially important to Ceola, as a breast cancer survivor, is encouraging women of any age to follow the advice of their doctors about mammograms. It saved her life.

Although they have lived in Silver Spring, Hyattsville, and DC for over 40 years, Leisure World was not on their radar. When stairs and yard maintenance became challenging, they began thinking about moving. They were not just looking for a house; they were looking for a community. They were surprised but delighted that LW is just that. Although they moved into Mutual 16 a short time ago, they already participate in water aerobics, the writers' club and the short story book club. They say everyone here has been welcoming and they have found the community they were looking for.

In the 1970s, Ceola and Peter appeared on The David Susskind Show. The theme was interracial couples, a rare phenomenon in those days. Mr. Susskind's question was: "Why?" Their answer: "Because we fell in love." Today, nearly fifty years later, the answer remains the same.

These concepts show weatherproof acrylic elements that would be mounted on wood frames created and built in the Leisure World Woodshop.


The purpose of these renderings is to stimulate further discussion within our community.

Keep it updated with info concerning medications, doctors, and contacts to be notified in case of serious illness. ROBO-CALLS:

The Mutual 16 President directs the robo-call system to alert residents about immediate situations in the mutual. It may be a notice about a repair that affects residents' water service, a last-minute change to a meeting time, or even a "silver alert" for a missing vulnerable neighbor. **Ellen Darr** manages the robo-call directory. To remove your listing, or switch it from land-line to mobile, contact ellenmdarr@gmail.com

TRASH SCHEDULE

Here's the schedule for garbage and recycling pickups, with specific requirements for each. Note: garbage and recycling night before their pickup days.

- GARBAGE: Pickup days are Tuesday and Friday. Be sure your garbage can is tightly covered.
- GLASS/METAL/PLASTIC RECYCLING: Pickup days are Tuesday and Friday. Recycling should be in the appropriate blue container. If you need a blue container, you can get one from PPD.
- PAPER/CARDBOARD RECYCLING: Pickup day is on Wednesday only. Paper/cardbood should be placed in a blue recycling container. Large boxes may be set out separately. Secure properly so paper doesn't fly around when it's windy.
- YARD DEBRIS: BY REQUEST ONLY on Monday and Thursday. Contact the Grounds Department 301-598debris for pickup. Use tall brown paper recycling bags. Phone calls are preferred, but you may also email grounds@lwmc.com.
