# FROM THE DESK OF THE PRESIDENT

It is the Mutual 16 Board of Directors' duty, by law and by common sense, to know what is going on in the Mutual. You have given the Board the responsibility to oversee changes to the Mutual in order to maintain a consistent and harmonious Mutual esthetic. In three pages of legal-ese, Article X, Sections 1-6 of the current bylaws basically say that you cannot make any changes to the outside of your house or any structural changes to the inside unless you get the approval of the Board of Directors (BOD). We have a few new neighbors and now is a good time to go over the process for getting Board approval for changes to your unit.

- If you want to change anything outside of your house, you are supposed to fill out an Application for Building Modification (ABM) and submit it to the Board for approval. If you are planning to make a change but are not sure if you need an ABM, ask.
- If you are using a contractor for a large project (like new windows, moving a wall, adding electrical boxes), you will need to have the contractor's license number and a copy of the contractors Certificate of Insurance with Mutual 16, Leisure World of Maryland Corporation, and yourself listed as additional insured. This ABM goes to our Property Manager for a recommendation, then to the BOD for approval. When in doubt, ask.
- If you are planning a smaller project (painting your door, selfinstalling a security system), you may not need the contractors' information and the ABM can go directly to the BOD for approval. When in doubt, ask.
- Either way, include a detailed description of what you want to do.
- You can get an ABM form from any member of the Board, the Mutual Property Manager, the Mutual Admin Assistant, or you can get it online at <u>www.lwmc.com</u> or <u>www.lwm16.com</u>.
- Most ABMs are approved. Many inside changes, even major ones, do not require an ABM. When in doubt, ask.
- If you have a question, talk to a Board member, our Mutual Property Manager, or our Mutual Admin Assistant. Their phone numbers and emails appear on this page. When in doubt, ask.

Let's keep Mutual 16 beautiful so it will always be known as the Potomac of Leisure World. If you are in doubt about what that means, ask.



You will have to imagine the details of Jackie's career but she worked with several Presidents, First Ladies, Ambassadors, and other high-ranking officials throughout her career. At the same time, she was her daughters' school room mother which involved playground duty and birthday cupcakes. She was also their softball coach, never missing a game.

While Heather's mother spent her career on one path – national security – Heather's path has had a few twists and turns. In grade school and high school (Holy Redeemer, Holy Cross, and Einstein), Heather was academically average but socially superior. She excelled in making friends, many of whom she has to this day. Upon high school graduation, Heather got a job in a dentist's office and worked her way up from dental office assistant to office manager. She had always been interested in public safety. After work and on weekends, she volunteered with Montgomery County Fire and Rescue. She became certified as an emergency vehicle operator, driving advanced lifesupport ambulances. She also became an Emergency Medical Technician. All this was as a volunteer. When she was laid off from the dentist's office, she decided to get paid for what she loved to do. She applied to be a dispatcher for the Arlington County Emergency Communications Center where they send fire, police, and ambulances to people in trouble.

She worked her way up again and is now training manager for all the dispatchers in Arlington County.

When Heather was a EMT in Montgomery County at Kensington Fire Stations 5 and 21, she came to Leisure World all the time. She was drawn to it. From her 20s on, she said she wanted to live in Leisure World. It took her mother a lot longer to be convinced of the appeal of Leisure World.

Jackie suffered a severe broken leg in 2019. Heather moved into her mother's house to take care of her after several surgeries. During her 15-month recovery, they found that living together worked. When Jackie decided it was time to downsize and have some (but not too much) yard work, it was Heather who talked her mother into moving to Mutual 16.
